



# Terms and Conditions

The purchase of your travel booking constitutes a contractual agreement between the traveler(s), customer(s), and/or purchaser(s) (collectively as "**You**", "**Client**" and "**Traveler**"), and Fun and Leisure Travels, LLC dba Fun and Leisure Travels dba Fun and Leisure dba FLT ("**Fun and Leisure Travels**", "**We**", "**Us**") pursuant to the following terms and conditions ("**Terms**", "**Agreement**"):

**TRAVEL AGENCY/AGENT/ADVISOR/CONSULTANT:** Fun and Leisure Travels acts as a travel agency/agent/advisor/consultant. We sell various travel-related products on behalf of numerous transport and accommodation service providers, including, but not limited to, airlines, bus, rail, cruise line operators, tour operators, and hotels. Fun and Leisure Travels does not own, operate, manage, or control these independent suppliers of services and is not liable for their acts or omissions. Fun and Leisure Travels' obligations to you are to make travel bookings on your behalf and to arrange relevant contracts between you and the travel service providers. We have no responsibility for these services, nor do we have the authority to make any warranty or representation regarding their standard. Requests cannot be guaranteed. All bookings are subject to the terms and conditions and limitations of liability imposed by these travel service providers. You understand that your legal recourse is against the specific provider, not Fun and Leisure Travels. Conditions can change rapidly in a country at any time. It is your responsibility to check the USA Government Travel advisories for your intended destination at [travel.state.gov/content/travel.html](http://travel.state.gov/content/travel.html).

**USE OF FUN AND LEISURE TRAVELS SERVICES, ACCESS, AND INFORMATION FOR TRAVEL BOOKINGS:** You warrant that you are at least 18 years of age and possess the legal authority to enter into this Agreement and to make travel arrangements with Fun and Leisure Travels. You agree to be financially responsible for all of your travel bookings made on behalf of yourself and any member of your traveling party and warrant that all information supplied by you on behalf of yourself, members of your household, or others for whom you are authorized to transact business with us is true and accurate. You agree that you will only make legitimate reservations or purchases with Fun and Leisure

Travels and its Suppliers, and acknowledge that, without limitation, any speculative, false, or fraudulent reservation is prohibited.

All bookings are accepted by Fun and Leisure Travels as agents for the travel Suppliers on your itinerary. Separate Supplier terms and conditions will apply to your reservation and purchase of travel-related goods and services that you select, and you understand and agree to abide by the terms and conditions of purchase imposed by any Supplier that you have selected as a service provided on an itinerary you have approved. It is the client's responsibility to find each Supplier's terms and conditions if not provided to them by Fun and Leisure Travels.

Fun and Leisure Travels is an independent Affiliate of KHM Consulting dba KHM Travel Group, dba KHM Travel dba KHM.

**PROPOSALS AND PRICING - IMPORTANT CONDITIONS:** Fun and Leisure Travels will research and propose one or more potential travel proposals with pricing and availability subject to change until final payment is made. Fun and Leisure Travels in almost all cases will provide a minimum of one choice of travel protection. If travel protection is not chosen a waiver must be signed by you. At the time we provide you with a quote, prices displayed may or may not be inclusive of all government and supplier taxes and/or fees for your booking and the total price will include any service fees charged (as more particularly described below). Some Suppliers have added service charges, port fees, etc that will not display on the quote. Prices are always subject to change before final payment is processed. Prices are not subject to increase after you make full payment, except for changes by client and/or charges resulting from increases in government-imposed taxes or fees. U.S. or international government-imposed taxes and fees may apply on arrivals and departures depending on the itinerary chosen and are payable to the appropriate airport authority. By agreeing to these Terms, you expressly acknowledge your acceptance of these conditions (i.e., increases before full payment and increases attributable to government-imposed taxes or fees after full payment will be your responsibility) applicable to your purchase. Additional taxes and surcharges that cannot be pre-collected may be charged locally by car rental agencies, hotels, or other suppliers. Most properties and vehicle rental/leasing companies require a credit card imprint at check-in. Please refer to each rental/leasing company's terms and conditions for deposit holds and use of any debit cards/checks and/or cash.

**TRAVEL AGENT CONSULTING FEES:** Fun and Leisure Travels will charge the following non-refundable, non-transferable fees for consulting fees on travel inquiries, research, and/or travel bookings:

#### **Consultant Fee Structure**

- Pick my brain Fee: **\$50 per vacation type**

- Domestic Air Ticketing Fee, per person: **\$50**
- International Air Ticketing Fee, per person: **\$100**
- Individuals/Couples/Small Groups for up to 4 rooms, per booking: **\$100**
- Larger families/groups/extensive itineraries, per booking: **\$100 or more**
- Trip Cancellation or Change Fee, per person: **\$100 in addition to any supplier penalties**

The consultation Fee is valid for thirty (30) days from submission by Fun and Leisure Travels to Traveler of a proposed travel plan. If the finalized travel plan is not booked within the sixty (60) days of Fun and Leisure Travels submission, then a further Consultation Fee may be charged for further inquiries.

Consultation Fees are charged per “payor,” (i.e., if you are the payor for more than one traveler or room in your purchase you will only be charged the Consultation Fee once, not for every traveler or room in your purchase). The Consultation Fee is charged whether or not you finalize the travel booking and is in addition to the total cost of travel booked.

Notwithstanding the above, you may choose to pay \$300 per payor for unlimited travel consultations valid for 12 months from the date of purchase (“**Annual Consultation Fee**”)

**PAYMENTS AND CANCELLATIONS:** You will be required to pay a minimum deposit based on each supplier's terms and conditions when booking. Fun and Leisure Travels accepts debit cards or credit cards, and all amounts are paid directly to the supplier. Fun and Leisure Travels will only charge your debit and/or credit card to Fun and Leisure Travels for the consulting fee. Should you wish us to charge your debit/credit card, we may require you to read and sign a credit card charge form set out in the receipt. You agree that any fees charged by Fun and Leisure Travels are non-refundable, including without limitation the Consultation Fees, Service Fees, cancellations fees, and/or the Change Fee unless a Suppliers terms and conditions state otherwise and/or your travel insurance plan includes a refund for certain expenses and/or fees.

You shall be completely responsible for all charges, fees, duties, taxes, and assessments arising out of your travel bookings through Fun and Leisure Travels. By submitting a credit card authorization form to Fun and Leisure Travels, you agree to allow Fun and Leisure Travels to use your payment method to purchase travel products from our Suppliers on your behalf and to use a said payment method to pay for Fun and Leisure Travels consultant fee and any change or cancellation fees if they shall arise. Excepting in cases of fraud, you agree not to file any dispute with your bank or credit card company to avoid or violate any booking terms and conditions of Fun and Leisure Travels or its suppliers, including cancellations or changes of itinerary or arrangements for reasons beyond the control of Fun and Leisure Travels or its suppliers. If you attempt to chargeback, reverse, or recollect a previously authorized trip payment, Fun and Leisure Travels reserves the right to collect all additional costs, fees, and expenses

associated with such chargeback, reversal, or recollection, including, without limitation, court and/or attorney fees. If the credit card is declined, you guarantee that you will settle any amounts owing to Fun and Leisure Travels via money order or cash immediately or within 10 days.

All payments for travel are due before departure according to each Supplier's terms and conditions of booking. You understand that failure to make final payment or any violation of a Supplier's conditions of purchase may result in cancellation of your reservations, in your being denied access to any flights, tours, hotels, cruises, or other travel services, or in your forfeiting any monies paid for your reservations. In some cases, there is NO REFUND once a booking is made and under deposit. You may not be entitled to a refund if you change or cancel your travel plans after confirmation of a booking. All cancellation requests must be sent to Fun and Leisure Travels in writing. If a travel component is changed or canceled by the client without letting Fun and Leisure Travels know in writing then in no way is Fun and Leisure Travels liable for any refunds by the Supplier and is not responsible for working with the Supplier to obtain such refund. As a result of cancellation, Fun and Leisure Travels and third-party Supplier's cancellation penalties will apply. Cancellation fees will be charged to the credit card or other payment method you authorized to pay for travel services or deducted from the Supplier's refund.

**Change Fees:** Once a travel booking has been confirmed and deposit(s) and/or full payment received, Fun and Leisure Travels reserves the right to charge a \$100 non-refundable change fee ("**Change Fee**") for date changes made at your request for each adult travel booking changed. This Change Fee is in addition to any change fees charged by the travel service provider(s).

**Cancellation Fees:** Once a travel booking has been confirmed and deposit(s) and/or full payment received, Fun and Leisure Travels reserves the right to charge a \$100 non-refundable cancellation fee ("**Cancellation Fee**") for cancellations made at your request for each adult travel booking changed. This Cancellation Fee is in addition to any cancellation fees charged by the travel service provider(s).

**Supplier Refunds:** Please be aware that most travel bookings are non-refundable and cancelled bookings will incur charges. These charges can be up to 100% of the cost of the booking, regardless of whether travel has commenced. Please refer to the Supplier terms and conditions. Fun and Leisure Travels is not liable for any supplier refunds.

**Baggage Fees/Seat Choices:** Additional fees for baggage and seat choices may apply as determined by the airlines. Please contact your airline or refer to its website for detailed information regarding its checked baggage policies for more information.

**TRAVEL DOCUMENTS, INCLUDING TSA AND DHS ACCEPTABLE IDENTIFICATION REQUIREMENTS:** Travel documents include, without limitation, airline tickets, hotel vouchers, tour vouchers, or any other document (whether in electronic form or otherwise) used to confirm an arrangement with a service provider. Travel documents

may be subject to certain conditions and/or restrictions such as, but not limited to, being non-refundable, non-date-changeable, and subject to cancellation and/or amendment fees. It is the responsibility of each Client to obtain and carry a valid passport, visa(s), and all other documents required by applicable government regulations. When traveling domestically or internationally, the U.S. Transportation Security Administration (TSA) and U.S. Department of Homeland Security (DHS) advise that everyone carry acceptable identification in order to board a flight. The name, date of birth, and gender that appear on the identification must exactly match the same data that is listed on airline ticket(s) and booking records. You acknowledge any failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing Client to miss flight(s), and subsequent scheduled travel bookings on cruises and tours. Any errors in names, dates, and timings on your documentation will be your responsibility if we are not advised at the time of booking.

When you receive any and all travel documents, it is your responsibility to review and verify all information for accuracy. Contact Fun and Leisure Travels immediately if changes or corrections are required.

**Passports:** All individuals departing from the United States of America must be in possession of a valid passport. Please check that your passport is valid for at least 6 months beyond your intended travel time. It is your responsibility to ensure that you have valid travel documentation, including but not limited to passports, real IDs, vaccination certificates, and visas, which meet the requirements of immigration and other government authorities at every destination. You are responsible for confirming with the United States Department of State or the representative government agency of the country to which you are traveling to confirm the requirements for visas and/or other requirements for admission to your destination. Any fines, penalties, payments, or expenditures incurred as a result of such documents not meeting the requirements of those authorities will be your sole responsibility.

**REAL ID:** Beginning May 7, 2025 (such other date as prescribed by Homeland Security), if you plan to use your state-issued ID or license to fly within the U.S., it is your responsibility to make sure it is REAL ID compliant. If you are not sure if your ID complies, please check with our local state Department of Motor Vehicles, or visit [www.tsa.gov/real-id](http://www.tsa.gov/real-id).

**Minors Traveling:** Children and infants also require travel documents. Minors traveling with one parent, and/or without both parents, may be stopped and not admitted, unless approved and verified consent forms are provided to the authorities; please see the entry requirements for the country you are visiting for more information and for the necessary forms that may be required.

**VISAs:** Additionally, a visa may be required. Please note that even when a visa is issued, a traveler may be denied entry since each country's local immigration officials make the final entry decision. Several factors including past criminal record may contribute to the decision of the local immigration official(s). Should a visa not be issued, **Fun and Leisure Travels** is not responsible for lost payments made toward the contemplated trip.

**INDIVIDUAL ENTRY AND EXIT REQUIREMENTS:** Each country holds different views of past criminal offenses, whether within or outside of its boundaries. If you have a current or prior criminal offense, contact that country directly for entry and exit requirements. If traveling to or through Canada, travelers with a Driving While Intoxicated (DWI) or other conviction record should always check whether current rules exclude admission. Fun and Leisure Travels feels it is an invasion of privacy to make such an inquiry of you. The final decision of entry rests with the immigration or border services officer. **REFUSAL OF SERVICE:** Service providers reserve the right to refuse service to travelers at their sole discretion, including, without limitation, if the traveler: (i) Lacks proper documentation for the country of destination; (ii) Does not comply with the service providers policies and procedures, including without limitation being resident of a country that the service provider has decided does not meet their travel requirements; (ii) Has a contagious disease; (iii) Is under the influence of alcohol, drugs, or narcotics; and/or (iv) Manifests disruptive and/or unruly behavior. Fun and Leisure Travels assumes no liability for the acts of the service provider in refusing service.

**HAZARDOUS MATERIALS:** Federal law prohibits passengers from bringing hazardous materials on the aircraft. (1) Federal law forbids the carriage of hazardous materials aboard aircraft in the passenger's luggage or on the passenger's person. A violation can result in five years imprisonment and penalties of \$250,000 or more (49 U.S.C. 5124)/ Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives, and radioactive materials. Examples: Paints, lighter fluid, fireworks, tear gases, oxygen bottles, and radiopharmaceuticals. (2) There are special exceptions for small quantities (up to 70 ounces total) of medicinal and toilet articles carried in the passenger's luggage and certain smoking materials carried on the passenger's person. **INSECTICIDE NOTICE:** We recommend that you refer to the DOT list of airports in countries that require airlines to treat the passenger cabin with insecticides prior to the flight or while on the aircraft. **HEALTH AND SPECIAL REQUIREMENTS:** It is your responsibility to ensure you are aware of any health requirements, health advisories, or health travel restrictions applicable to your travel destinations and to ensure that you carry all necessary vaccination documentation. Fun and Leisure Travels is not responsible for providing you with this information. Travel carriers and local authorities at travel destinations may require specific testing prior to boarding and/or upon arrival at your destination, including, but not limited to, a temperature check as a result of the COVID-19 pandemic. You may be denied entry onto your carrier and/or entry upon arrival at your destination, or be required to self-quarantine at your destination and upon your return to the United States. You must comply with local government regulations. Additional costs are your responsibility. **AIR TRAVEL, SCHEDULE RECONFIRMATION, CHECK-IN:** Fun and Leisure Travel shall not assume any responsibility for any air schedule changes. In rare instances, upon departure from a country, certain departure taxes must be paid in cash only and may vary in price. Failure to use a reservation may result in automatic cancellation of all continuing and return flights, as well as forfeiture of airfares.

Airline e-tickets expire a year from the issue date unless carrier fare rules in the passenger's itinerary fare provide otherwise.

Due to enhanced security, it is strongly recommended that you arrive at the airport and check in a minimum of 2 hours prior to scheduled departure for domestic flights and 3 hours prior to scheduled departure time for international flights. Reconfirm flight times at least 24 hours prior to scheduled departure for domestic flights, and 72 hours prior for international flights.

**RIGHT TO CORRECT ERRORS/OFFERS SUBJECT TO AVAILABILITY:** We reserve the right to correct errors. In the event of any pricing error or omission, we reserve the right to adjust such pricing or make any other corrections. All offers, incentives, and Supplier promotions are subject to availability and may change without notice. Prospective Clients are advised to reserve early to avoid disappointment, increases in fares, and additional late booking fees.

**UNUSED ARRANGEMENTS, MINIMUM PASSENGER REQUIREMENTS, AND ALTERATIONS TO BOOKINGS:** When tour, cruise, or package prices are based on the Supplier's contract rates, you will not be entitled to any refund of any unused portion of travel.

Some group tours are based on the minimum number of passengers traveling; if the number of passengers falls below the minimum required, a surcharge may be imposed, or the tour may be canceled. Any cancellations of a tour or package for reason of failing to

meet the minimum traveler requirement will be governed by the tour operator's cancellation policy.

The Supplier may determine that alterations in itinerary are necessary for any number of reasons, including but not limited to severe weather. Any alterations to an itinerary are at the sole discretion of the Supplier, and Fun and Leisure Travels bears no responsibility for any changes.

**RISKS/SAFETY:** Travel to certain destinations may involve greater risk than others. Fun and Leisure Travels urges Clients to remain informed on a daily basis as to current news events, as well as to review travel prohibitions, warnings, announcements, and advisories issued by the United States Government prior to booking travel to international destinations. By offering for sale travel to particular destinations, Fun and Leisure Travels does not represent or warrant that travel to such points is advisable or without risk, and shall not be liable for costs, damages, or losses that may result from travel to such destinations. The client's participation constitutes acceptance of such events at the client's own risk.

**TRAVEL INSURANCE/PROTECTION:** For your protection, Fun and Leisure Travels strongly recommend that you purchase travel insurance. However, no representation or description of the insurance made by Fun and Leisure Travels to you constitutes a binding assurance or promise about the insurance. Fun and Leisure Travels is not an insurance company and has no responsibility for the submission, payment, or adjustment of any insurance claims.

Unless noted, travel insurance is not included in the cost of the Client's itinerary and/or proposal to protect against third-party supplier default/bankruptcy protection, delay, interruption, missed connection for cruises, cancellation, medical emergency transportation/evacuation & repatriation, baggage & person effects/lost luggage & baggage delay, illness, job loss protection and change of plans, accidental death and disability, travel accident/sickness medical expenses, and more.

Without appropriate travel insurance, Client understands and agrees that if Client cancels or interrupts Client's travel for any reason, portions of the trip/tour may not be



refunded and Fun and Leisure Travels and travel Suppliers' cancellation penalties will apply resulting in the loss of monies up to the full cost of Client's travel booking and related costs. The purchase of travel insurance is not required in order to purchase any other product or service offered by Fun and Leisure Travels, however, if you decline to purchase insurance, Fun and Leisure Travels will require that you execute an insurance waiver. Fun and Leisure Travels is not a licensed insurance broker, and its advisors are not qualified or authorized to answer technical questions about benefits, exclusions, and conditions of any of the insurance offered, nor evaluate the adequacy of the prospective insured's existing insurance coverage. An additional charge applies for any travel insurance selected.

Fun and Leisure Travels cannot guarantee that any insurance provider will approve coverage for a claim made under the insurer's policy and makes no representations about the extent of coverage for any policy it may offer or quote. Any insurance claims that may fall under the relevant travel insurance policy must be submitted to the insurance company identified in the policy.

**RESPONSIBILITY:** We always do our best to make sure your travel arrangements are satisfactory. However, Fun and Leisure Travels and its employees, shareholders, subsidiaries, affiliates, officers, directors, successors, agents, and assigns do not own or operate any entity that provides goods and services for your travel, including without limitation lodging facilities, airline, vessel, motor coach, or other transportation companies, guides or guide services, local ground operators, providers, or organizers of optional excursions, food service providers, etc. All such persons and entities are independent contractors and are in no way affiliated with Fun and Leisure Travels or any of Fun and Leisure Travels affiliated entities.

**LIABILITY AND FORCE MAJEURE:** Fun and Leisure Travels acts solely as a booking agent for disclosed principal Suppliers and is not the source or provider of any travel service. Each Supplier is an independent entity with its own management and is not subject to the control of Fun and Leisure Travels. The Suppliers whose names appear in travel documentation are those actually responsible for providing the travel services purchased, and you consent to the use of those Suppliers.

Fun and Leisure Travels is not liable for any negligent or willful act or failure to act of any travel service provider or of any third party. In addition and without limitation, Fun and Leisure Travels is not responsible for any injury, loss, death, inconvenience, delay, or damage to person or property in connection with the provision of any goods or services, whether resulting from, but not limited to, acts of God or force majeure, or unavoidable or extraordinary circumstances as defined below. Also be advised that certain foreign facilities or amenities, such as air-conditioning systems in public places, hotels, and motor coaches may not be up to U.S. standards. If due to weather, flight schedules, or other uncontrollable factors, you are required to spend additional night(s), you will be

responsible for your own hotel, transfers, and meal costs. Baggage is entirely at the owner's risk. You may see the name Fun and Leisure Travels affixed to motor vehicles, on signs around the hotel, or elsewhere. This use of our name is purely for reasons of identification and does not denote ownership, supervision, or control by Fun and Leisure Travels in any way. The prices of these tours are based on rates in effect (including foreign exchange rates) at the time of printing and are subject to change without notice. Under circumstances where liability cannot be excluded, such liability is limited to the value of the purchased travel arrangements. You specifically agree that Fun and Leisure Travels is not liable for any consequential loss or damage.

In the event of unavoidable or extraordinary circumstances, a travel service provider may materially modify or cancel your booking as set out below. In these Terms "unavoidable or extraordinary circumstances" means any cause outside a travel service provider's reasonable control which could not have been prevented or avoided even if all reasonable measures had been taken by the travel service provider (including, but not limited to, war, threat of war, riot, civil disturbances, industrial dispute, terrorist activity and its consequences, plague, epidemic, pandemic, infectious disease outbreak or any other public health crisis (including quarantine or other employee restrictions), natural or other disaster (such as volcanic ash or hurricanes or similar events), nuclear incident, fire or bushfires, adverse weather conditions (actual or threatened, including snow and fog), closed or congested airports or ports or other modes of transport, unavoidable technical problems with transport, unforeseen alterations to transport schedules, transportation disruptions or cancellations, domestic and/or international travel restrictions, changes to travel advisories and restrictions, changes to health advisories and quarantines, changes to immigration, labour and free-movement laws resulting from BREXIT, rescheduling of aircraft or boats or other modes of transport, changes to applicable laws and/or other government mandates (including evacuation orders and border closures), and similar events). A material modification is one that has a serious impact on your booking and would cause substantial inconvenience to you. Pursuant to the Final Rule (as defined above), in the event of a Significant Change you may be entitled to an Applicable Refund. In addition, pursuant to the Final Rule airlines may be required to issue travel credits for nonrefundable ticket holders who cancel travel for reasons related to a "serious communicable disease". Such travel credits are issued by the airline and the airline may require documentation from a licensed treating medical professional. Airlines may also be required to provide travel credits when passengers are prohibited from travel or required to quarantine for a substantial portion of the trip by a government entity.

In addition, each of Fun and Leisure Travels' Suppliers has terms and conditions which include Force Majeure provisions. In the event that a Force Majeure event occurs, those Suppliers may be entitled to, and may in their sole and absolute discretion, vary, postpone, or cancel any itinerary or arrangement in relation to the trip. Payment of any refund to you as a result of the non-performance of any obligations hereunder shall remain in the sole and absolute discretion of the Supplier, pursuant to their policies, although Fun and Leisure Travels shall use its reasonable efforts to secure reimbursement

for you where possible.

**ELECTRONIC OR HANDWRITTEN SIGNATURE:** Both parties agree that you may acknowledge and agree to these Terms: (i) electronically; (ii) by handwritten signature; (iii) by any other electronic means, including, without limitation, via email acceptance of these Terms; or (iv) by your implied consent deemed via your actions, which shall include without limitation the payment of the invoice and/or your use of the services provided by Fun and Leisure Travels or any other travel supplier related to your booking. All such means will be deemed to constitute effective acknowledgment and execution of this Agreement and shall be sufficient to bind the parties to the terms and conditions of this Agreement.

**AMENDMENT:** We reserve the right to modify any of these Terms at any time without prior notice. If we make changes to any of these Terms, we will post the amended terms and conditions on the website, applications, or services, which are effective upon posting. The applicable Terms that apply are those in effect at the time you make a booking with us.
